Health and Safety Policy

The purpose of this policy is to provide guidelines to ensure that risks to all those participating in the Centre for Ecotherapy's activities, in whatever role, are minimised as far as is practicable. There is a degree of risk in many activities and to prevent it completely is impossible and undesirable. The Centre for Ecotherapy believes that people learn, develop and mature when taking part in activities that challenge them and which sometime involve taking risks. Through exposure to these activities (such as fire lighting and cutting trees) people can increase their risk competence, developing skills to assess and manage risks, according to their age and ability. However what risk there is in a session will be thought about conscientiously and minimised where possible. Weighing up the risks and benefits will be achieved through using ongoing, relevant, dynamic assessments and active supervision in all sessions.

As well as the general guidelines outlined in this policy, specific procedures have been developed around fire, tool use and heavy lifting.

In general we will seek to:

- Monitor and control health and safety risks arising from our activities
- Be informed, through consultation with clients, volunteers, staff and others, about anything that may affect their personal health and safety
- Provide and maintain safe facilities, equipment and working conditions
- Provide information, training and supervision for employees and volunteers
- Minimise accidents and cases of work related ill-health
- Review and revise this policy at regular intervals

Specifically we will ensure that:

- An appropriate first aid kit and trained first aider will be available on site at all times.
- The Centre for Ecotherapy site, and all activities, are risk assessed by a competent person on a regular basis.
- New activities are reviewed with the group at the beginning of the day to ensure that everyone is aware of the potential hazards and risks and what they can do to minimise them.
- Accidents are recorded using the Accident Report Book. Accident books will be reviewed on a quarterly basis. Near misses are also recorded.
- Volunteers, when necessary, will receive training in Health and Safety.

Staff, volunteers and clients of the Centre for Ecotherapy should, at all times:

- Follow safety procedures.
- Exercise awareness, alertness, self control and common-sense.
- Be mindful of their own safety and the safety of others.
- Report promptly any hazards, equipment defects and health/safety concerns they may have.

Disciplinary procedures will be applied to staff, volunteers and participants who breach these guidelines.

Responsibilities

Overall and final responsibility for health and safety is the responsibility of the Appointed Health and Safety Officer.

Day-to-day responsibility for ensuring the policy is followed is delegated to the Project/Activity Co-ordinator.

To ensure health and safety is maintained/improved, the following people have responsibility for the following areas:

Risk will be assessed by the Project/Activity Co-ordinator.

- The findings of the risk assessments will be reported to the management team.
- Action required to remove/control risks will be agreed by the management team.
- Project/Activity Co-ordinator will be responsible for ensuring the required action is implemented and recorded as completed.
- Risk assessments will be reviewed every 6 months or when the activity changes, whichever is soonest.
