

Professional Directory Terms and Conditions 2021

The Centre for Ecotherapy (C4E) is committed to supporting and promoting the partnership of therapy and nature as a means of enhancing the therapeutic experience. To this end we have developed a Professional Directory for third party therapists and health professionals who *consciously and implicitly* facilitate their profession or therapy in a natural space or with natural elements as a part of the therapeutic process.

These are the Terms and Conditions for uploading a listing to the Professional Directory.

- 1. Within these terms and conditions, therapists and health professionals using the Professional Directory will be known as Professional Directory Members (PDMs) from here on.
- 2. In using the C4E website and Professional Directory you agree to these terms and conditions.
- 3. C4E accepts no responsibility for the accuracy of the statements made by Professional Directory Members (PDM). In uploading profile details to this directory, PDMs agree to be bound by their statements and accept liability for any issues that may arise from making misleading or false claims. The PDM is responsible for maintaining their listing and keeping it as up-to-date and accurate as possible.
- 4. On receiving a profile listing C4E reserves the right to publish or not publish said listing due to content or concerns regarding the listing or PDM themselves.
- 5. When uploading a profile, PDMs are required to show professional affiliation and qualifications in order to demonstrate professionality and adherence to a code of conduct specific to the therapy or health practice they are utilising. C4E are under no obligation to check these credentials before listing a profile.
- 6. All therapists and health professionals using the Professional Directory are expected to treat the natural environment with respect, striving to personally uphold and promote attitudes that underpin a sustainable and life-affirming relationship with their surroundings and the places wherein their respective therapies and health practices take place. Substantiated evidence of any sustained abuse of the natural environment during therapies and health practices advertised through C4Es Professional Directory

will incur removal from the Directory forthwith with no return of fee. Discussion on this matter is discretionary.

- 7. In maintaining the Professional Directory upon its website, C4E neither recommends nor patronises any individual listing. C4E holds no opinion as to the effectiveness nor validity of the therapies or health practices listed.
- 8. Acceptance of a profile listing into the Professional Directory does not infer any affiliation, endorsement or professional relationship between C4E and the PDM. The PDM does not have the right to claim any professional affiliation with C4E, nor professional endorsement by C4E, other than being listed in the Professional Directory.
- 9. C4E will not pass on details of the PDM to any third party organisation, in accordance with our Data Protection and Privacy Policy, unless required to do so by law, .
- 10.PDMs agree to pay the Professional Directory fee within one month of payment request or the listing will be removed. Fees can change on an annual basis. PDMs will be informed of change in fee and have the option to continue with the listing or remove it.
- 11.PDMs may edit their listing at any time. Edited information will be appraised by C4E before publishing.
- 12.All listings must adhere to the C4E Equal Opportunity Policy. Where therapy or health practices are aimed at single gender or race it is expected that this is for beneficial reasons and not to be discriminatory. The Centre for Ecotherapy expects that all people involved in transactions created through the Professional Directory will treat each other with respect, kindness and open-mindedness.
- 13.C4E may edit, discontinue or temporarily remove the Professional Directory from public view, at any time. DPMs will be informed if the Professional Directory is removed from view permanently.
